Repair of the King's Grant Sign

As many of you have probably noticed, a driver recently veered off the road and struck the King's Grant Sign. The right side of the sign was sheared off. Just before repairs were implemented, the Board decided to discuss whether to repair the sign or to apply the insurance proceeds to build a new sign. The sign is budgeted to be replaced in year 2016 with a cost estimate of \$20,000. Current solicitations resulted in pricing several thousand dollars higher. After spirited debate, the Board voted to repair the sign now versus replacing it. These repairs should be completed by the last week in August.

Upcoming Budget Hearings

The Association is beginning to develop both capital and operational budgets for next year (2015). We need your input and support in this process. On Tuesday, September 9th at 6:30 p.m., we will be holding annual budget hearings for each of the parcel/town home communities (Audubon Park, Hunter's Green, Lott's Landing, Georgetown Place, and Georgetown Townhomes). On Tuesday, October 14th at 6:45 p.m., we will be holding the annual budget hearing for the CSA General Fund (amenities) and the CSA Capital Budget. These meetings are your opportunity to hear the staff's proposals for the budgets and to make your feelings and recommendations known regarding projected assessments and spending. We strongly encourage you to mark your calendar and make plans to attend.

Community Yard Sale

The Association will be sponsoring the fall yard sale at the Southside Clubhouse on Saturday, September 6th. Participation is free to all Association residents, but you must pre-register in the Office no later than Thursday, September 4th. The number of slots is limited and will be filled on a first-come basis.

Changes to Pool Rules

At the August 12th General Meeting, the Board of Directors voted to amend the pool rules to add the following requirement that shows as rule #8 on the new list: "No removing, or hanging onto, or standing on the float line separating the shallow end from the deep end." The revised rules are effective immediately, and a copy can be obtained from the Gate Guard at each pool during normal pool hours.

Collections Procedures

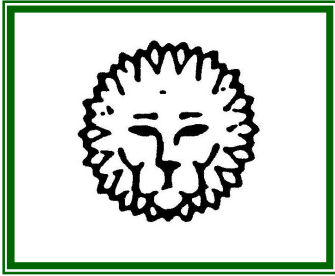
As a reminder, the Board of Directors voted on May 13th to amend the collections procedures for past-due accounts set for in Administrative Resolution 2012-3. The revised procedures are defined in Administrative Resolution 2014-2 which is available for viewing and printing from the Association's web site: www.georgetowncsa.com. The revision, which went into effect July 1st, adds a new criteria (shown below in bold italics) to paragraph 6 of the Resolution regarding when the remainder of the year's assessment will be charged to a member's account.

"When an account becomes over 60 days past due, ***or when an account becomes past due for the second time during a calendar year***, the remainder of that year's assessments are added to the account and are due in full at that point."

The remainder of the collection procedures are unchanged. As a reminder, payments are due on the first of each month and become past due after 30 days.

2014 Pool Season Almost Over

There are only a few weeks left in the current pool season, so don't miss out! Pools at both clubhouses are open seven days a week from 10:00 a.m. to 8:00 p.m. through Labor Day (September 1st). Pool Registration Cards are available at the Southside Office and at the pool gates during pool season. Cards must be completed and turned in by an authorized adult (GCSA Homeowner or Renter) prior to being granted pool access. If your child does not have some sort of picture ID, please provide a small recent picture along with your card and we will attach it to the back. Guest policy remains at a limit of 6 guests per season, and only adults may sign in a guest. Our pools will be operated under a "swim at your own risk" policy. Since no lifeguards will be on duty, parents/adults will have to take full responsibility for conduct and safety in and around the pools. Georgia law requires that children 14 years and younger be accompanied by an adult (21 and over).

Lott's Landing Parking Lot Repairs

The repairs, which were projected in the current Reserve Study and included in the 2014 Capital Budget, were designed to replace broken sections and fill large cracks to prevent future damage from water intrusion. The Association appreciates the demonstrated cooperation of the residents during these repairs.

Remember, this dumping is reducing your property values and is costing the Association money to remove it. Your cooperation in this would be greatly appreciated.
